MEMBERSHIP FEES

Single membership £10 annually. The membership year runs to 30 April and renewal fees are payable in May of each year.

New members joining between 1st February and 30th April need only to pay £5 for the period from joining to the following 30th April. A renewal fee of £10 would be payable in May.

These fees include £3.50 per capita fee paid to our National Organisation, the Third Age Trust, which provides a wide range of services and benefits, including liability insurance cover. The payment to the Third Age Trust is based upon membership numbers at 31st March each year.

From May 2017 all members not using email will also be required to pay a postal levy of £5 per postal address. For couples the postal levy will be charged to the first enrolled member.
