East Lothian u3a MEMBERSHIP FEES

Membership is £20 annually from 1st May to the following 30th April. New members joining between 1st January and 31st March will pay the basic £10 fee only, as they are joining for part of the year. A joining fee of £20 will be payable by new members joining in April (for 13 months membership), and all other members will pay the £20 renewal fee in the following May.

The cost of basic membership subscription is £10 and Gift Aid can be claimed on this amount. This fee secures membership of the EL u3a only and does not secure rights to personal use of any facilities or services provided by the u3a. The fee includes £4.00 that is paid to the Third Age Trust (TAT), the national organisation that supports u3as in the UK. TAT provides a wide range of services and benefits, including public liability insurance cover. The additional £10 of the EL u3a £20 membership fee covers the extra cost associated with attending interest groups and meetings.

TERMS AND CONDITIONS OF MEMBERSHIP All members agree to:

- Abide by the Principles and Member Code of Conduct of the u3a movement.
- Always act in the best interests of the u3a and never do anything to bring the u3a into disrepute.
